Appeal for a School van for children Friends,

The children at Parivaar go to 3 different formal schools in the morning. Currently we send the children through auto-rickshaws, public transport etc. Even with the best possible arrangements there is a degree of insecurity. We are trying to raise funds for a School Van (say a 30 seater) so that in multiple trips we can safely and comfortably send to schools.

The cost of such a School Van varies from Rs. 6 Lakhs to 8 Lakhs depending upon the make (Mahindra, Tata, Swaraj Mazda, Eicher etc.) and exact specifications. It would be immensely helpful if you could disseminate among your friends about this and motivate them to contribute whatever they can for this. We hope to make this School Van purchase as a New Year gift for the children.

If the corporate you are working in could sponsor it we would heartily welcome that. So you may contact the concerned people in your organization regarding the same. God has His own ways to make things happen. Who knows from where what help may come?
